- 1. I agree to comply with the rules, regulations and event instructions of the Ambros Inc 75<sup>th</sup> Anniversary Fishing Tournament.
- 2. Participant Waiver and Release. In consideration of accepting this entry, I attest that I am physically fit and have been sufficiently trained for this event. I voluntarily participate in this event with full knowledge that boating, fishing and related outdoor activities are inherently dangerous activities and may be hazardous to me and to property owned by me or in my possession, custody or control. I voluntarily assume full responsibility for any risks of loss, property damages, or personal injury, including death, that may be sustained by me as a result of participating in the event. I hereby, for myself, heirs, executors, and administrators, release, discharge, agree not to sue, and agree to indemnify and hold harmless Ambros Inc., its officers, directors, members, associates, volunteers, insurers, and event sponsors (the "Releasees"), from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me or in my possession, custody, or control, in connection with my participation in the event, whether caused by the sole or partial negligence of Releasees or otherwise.
- 3. Parent/Guardian Consent & Waiver and Release (for Minor). I am the minor's parent or guardian and I understand the nature of the fishing derby event and activity and verify and consent to the minor attending and/or participating in the event and activity. I attest that the minor is physically fit and has been sufficiently trained for this event. I voluntarily agree that the minor may participate in this event with full knowledge that boating, fishing and related outdoor activities are inherently dangerous activities and may be hazardous to the minor and to property owned by the minor or in the minor's possession, custody or control. I voluntarily assume full responsibility for any risks of loss, property damages, or personal injury, including death, that may be sustained by the minor as a result of participating in the event. On the minor's behalf, I understand and agree to assume all of the foregoing risks and accept sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, cost or expense of any kind, including attorney's fees, that the minor may experience or incur in connection with the minor's behalf, intending to be legally bound for myself and for the minor, and

for my and the minor's heirs, personal representatives, next of kin, and anyone who might make a claim on my or the minor's behalf, hereby release, discharge, agree not to sue, and agree to indemnify and hold harmless Ambros Inc., its officers, directors, members, associates, volunteers, insurers, and event sponsors (the "Releasees"), from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by the minor, or any of the property belonging to the minor or in the minor's possession, custody, or control, in connection with the minor's participation in the event, whether caused by the sole or partial negligence of Releasees or otherwise.

- 4. I hereby consent to receive medical treatment which may be available in the event of illness or injuries suffered by me during the event and authorize the release of medical information related to my condition.
- 5. I agree to permit the use of my name, picture and/or interviews for any broadcast, advertisement, film, videotape or any other account of this event without any form of payment or compensation.
- 6. TAXES. Winners shall be responsible for the payment of any taxes imposed by the Government of Guam or any other taxing authority as a result of Winner's receipt of cash prizes in excess of \$600; whether single or cumulative. Winners MUST provide AMBROS with Winner's social security number, mailing address, and contact number to receive any, and all winnings from tournament. AMBROS shall issue a Form 1099 to Winners for the cumulative total of the cash prize.
- 7. **SCOPE OF RELEASE AND INDEMNITY.** The Releasor acknowledges and further agrees that the foregoing Release of Lability and Indemnification Agreement is intended to be as broad and inclusive as is permitted by the laws of Guam, and that if any portion of it is held invalid, it I agreed that the balance shall, notwithstanding, continue in full legal force and effect.
